# What is Infant Mental Health Endorsement?

#### **Endorsement** is:

- Professional development
- Focused on prevention, promotion, and intervention for healthy social/emotional development
- For professionals who work with infants, young children, their families and primary caregivers
- Awarded in 4 different classifications: I-Infant Family Associate, II-Infant Family Specialist, III-Infant Mental Health Specialist, IV-Infant Mental Health Mentor



# The Endorsement Process... Where Did it Come From?

- Infant Mental Health Endorsement process developed in Michigan
- By mid-1980's educational core competencies had been identified and developed by Michigan
- By 1997 Mi-AIMH developed its Endorsement system in a 4-level framework
- Final phase of the process in 2000 with development of the examination
- Kansas is one of 23 other states and 1 international association that have purchased the endorsement program



### Who is eligible for Endorsement?

- Multiple disciplines working with children, prenatal to three and their families.
- Includes mental health, early care and education, medical, health, social welfare, special needs, judicial systems, educators, policy makers, and researchers.



### Additional criteria for Endorsement

- Written portfolio requiring comprehensive documented descriptions in 8 competency areas
- Proctored written exam (Level III & IV)
  - Level IV is separated into:
    - Clinical Supervision, Consultation and Training
    - Teaching, Research and Evaluation
    - Policy/Program Administration
- Ongoing continuous education following endorsement

### Am I LEVEL I: Infant Family Associate?

- I have at least CDA, Associates Degree or 2 years early childhood experience
- I've been working in the infant/early childhood/family field for 2 years
- I have at least 30 hours of IMH in-service training





### Am I LEVEL II: Infant Family Specialist?



- I have a Bachelor or Master's Degree
- I've worked in the infant, early childhood and family field for at least 2 years
- I have at least 30 hours of in-service training in IMH
- I have at least 24 hours of reflective supervision focused on infants and young children within 2-years



#### WHAT IS REFLECTIVE SUPERVISION?

- It goes beyond regular supervision in focusing on how I feel about my work
- It helps me think about what I do and understand how I work with families and their young children
- It is provided on a regular schedule by a supervisor whom I form a relationship with and trust
- It may occur individually or in a group





### Am I LEVEL III: Infant Mental Health Specialist?

- I have a Master's or Post-graduate degree
- I have 2 years post-master's work in the infant, early childhood, and family field working with caregiver and infant
- I have at least 30 hours IMH in-service training
- I have at least 50 hours of reflective supervision focused on infants and young children within 2 years
- A written exam to take offered by KAIMH





## Am I LEVEL IV: Infant Mental Health Mentor?

- I am a leader in the field; mentoring others
- I have at least a Master's degree and 3 years post-master's work in the infant, early childhood, and family field
- I may fit best in a clinical, policy, or training/research track
- If clinical, I have had at least 50 hours of reflective supervision focused on infants and young children within 2-years
- Level IV applicants will also have a written exam to take offered by KAIMH



#### What is the value of Endorsement?

- Provides a level of assurance to families, agencies and the public at large that the person delivering services meets professional standards.
- Provides a pathway for development in the infant and family field.
- Provides a set of competencies to guide training, service, policy and research.



## What is the value of Endorsement?

Endorsement criteria is identified to assure best practice:

- specific educational experiences
- work experience with infants, toddlers, young children & families
- competency-based, in-service training experiences
- reflective supervision/consultation experiences that focus on prenatal to three population
